WHEREAS AS the State Agricultural University (SAU) namely Birsa Agricultural University (BAU) through its Research Stations/ Sub-Stations / KVK upholds the mandate of generating, assessing and refining technologies, relevant to different farming situations, in the State of Jharkhand.

WHERE AS the other implementing partners such as MANAGE, Hyderabad and SAMETI, Jharkhand will oversee the operationalization of MOU through Director, SAMETI, Jharkhand.

#### CLAUSE-I

- 1.1 The State Agricultural University (SAU) i.e. Birsa Agricultural University (BAU) shall provide technological and methodological support to ATMAs for further dissemination to farming community.
- 1.2 In ATMA Project districts, concerned Research Station/ Sub-Stations/ KVK will carry out farmer participatory research trials (on farm and on Station trials wherever necessary) to generate location specific recommendation suitable to various farming situations of the district.
- 1.3 The farmer participatory research trials designed by BAU/KVK/ ZRS will aim at sharpening the focus of public Agriculture Technology System (ATS) with an emphasis an location specific, system based and sustainable technologies.
- 1.4 The technical training needs of different stakeholders like Governing Board Members, Management Committee members, Block Technology Team members, Farmers Advisory Committee members and Farmers Interests Groups of ATMAs will be addressed by respective ATMAs in consultation with Scientist of Research Stations/ KVK.
- 1.5 For field level technical training programme being conducted periodically by ATMA through BTT, Scientists of Concerned BAU/KVK/ZRS will participate as resource persons as and when necessary.

#### CLAUSE-2

- 2.1 ATMA will provide required funds to BAU/ZRS/KVK to carry out the activities as specified in Clause-1.
- 2.2 The Comptroller, BAU or his representative at ZRS/KVK will retain the original vouchers of expenditure incurred towards conducting farmer participatory research trials by BAU/KVK/ZRS for audit at their end and submit the Xerox copy of vouchers along with Utilization Certificate & audit Certificate to Project Director ATMA at the end of the Kharif & Rabi season i.e. by end of February and August respectively.

- 2.3 The traveling allowance / support and daily allowance of Scientists of BAU/KVK/ ZRS engaged in farmer participatory research& other activities under support to State Extension reforms would be borne by concerned ATMA on submission of bills. The Scientists working with the Project will get Traveling Expanses as per State Govt./ University rule. Their tour diary and T.A. bills would be approved by concerned Drawing Disbursing Officer and forwarded to Project Director, ATMA or In-charge of concerned BAU/KVK/ZRS for payment.
- 2.4 For conducting participatory research trials the concerned Scientists will use their office vehicle using P.O.L from ATMA funds. Incase the vehicle is not available for any reason they may use hired vehicle at the approved rate of concerned ATMA. Each ATMA will intimate the approved rate of the vehicle to the KVK/ZRS & University.
- 2.5 Birsa Agricultural University will keep 10% of the fund utilized for the research trials as institutional charge, which includes cost of audit, by Charted Accountant etc. Concerned Project Director, ATMA will place the required funds with the Comptroller. The Comptroller, BAU will submit a utilization certificate to the effect of institutional charge to the Project Director, ATMA in the following format.



#### **ANNEXURE-A**

#### TERMS OF REFERENCE FOR THE ENGAGEMENT OF NGOS BY ATMA, .....

- 1. Association of NGO is sought by ATMA,..... towards development of farmers interest groups (FIGs/ WIGs) and farmers organization (FOs) in the district.
- 2. The NGO will operate with in the block assigned by ATMA,.....
- 3. NGO will attend BTT-FAC joint meeting at respective FIAC on scheduled date & time on fortnightly basis.
- 4. NGO will identify the potential 10 SHGs of the concerned block (not involved in ATMA activities) to be dovetailed with ATMA. List of SHGs to be mutually agreed by the NGO and ATMA, ..... and subsequently will be approved by Governing Board of ATMA.
- NGOs will strengthen the existing FIGs and new groups of farmers or farm women identified by them on record keeping and accounting procedure as per NABARD guidelines.
- NGO in collaboration with BTT & FAC will conduct need assessment of the groups and reflect the same in respective block action plan.
- NGO will assist the groups for conflict resolution, rendering information support for development of groups.
- NGO will develop the micro plan for each group in association with concerned BTT & FAC within 3 months from the date of execution of the agreement.
- 9. NGO will facilitate identification and documentation of success stories in respective blocks.
- 10. NGO will facilitate the groups for establishing linkage with various financial and credit institutions.
- 11. NGO will assist concerned BTT & FAC in evolving black level farmers federation and specific plan of action for such federation must be developed within 6 months & submitted to ATMA,.....
- 12. NGO will carry out specific managerial capacity building programmes for the groups as reflected in Block Action Plan and funded accordingly through FIAC account only on approval in joint BTT-FAC fortnight meeting.
