

**PROCEDURE OF NOMINATION OF NON-OFFICIAL MEMBERS OF ATMA  
GOVERNING BOARD AND FARMERS ADVISORY COMMITTEE (FAC)**

**A. Nomination of non-officials on ATMA GB.**

1. Dy. Commissioner cum Chairman, ATMA will invite at least 5 nominations from each category of the farmers in the prescribed format (Copy enclosed).
2. The suitable nominations from each category may be collected / filled up by the district officers of the agriculture and line departments with the help of BTT members.
3. PD, ATMA / Incharge Officer (if regular PD is not appointed) will scrutinize the nominations and submit to Chairman, ATMA for recommendation to Agricultural Commissioner / Secretary Agriculture.
4. Chairman, ATMA will recommend one nomination from each category strictly on merit basis to APC/ Secretary Agriculture for final appointment on ATMA GB.
5. The APC/ Secretary Agriculture will nominate / appoint the non-official members on ATMA GB on the basis of recommendations made by Chairman, ATMA.

**B. Nomination of non-official on FAC.**

1. To nominate non-official members on the FAC for the period of two years, the officer in charge of the BTT will collect the information on the farmers in the prescribed format.
2. The village level worker of the agriculture and allied department the innovative farmers in their jurisdiction and will fill up the detail information about the farmer in the prescribed format.
3. Officer in charge will collect 5 nominations from each category of the farmers to be nominated on FAC and compiled in the Score Card.
4. The officer in-charge of BTT and Chairman of FAC will jointly recommend one farmer on the basis of score obtained (Strictly on merit basis) to Chairman ATMA for nomination.
5. Chairman ATMA in consultation with ATMA GB will nominate one farmer from each category on the block level FAC for the period of 2 years.
