The conditions of providing services on contractual basis are as follows:-

- (i) Posts advertised shall be filled up only on contractual basis initially for a period of one year . The contract can further be extended up to the programme period on the basis of performance appraisal report.
- (ii) The total number of vacancies as indicated above will be filled up as per the requirement strictly in accordance with merit. Merit list will be prepared according to marks weightage pattern as prescribed in the Departmental Sankalp.
- (iii) The above contractual posts will be coterminous with the Project.
- (iv) Yearly Performance, Monitoring and Appraisal would be carried out to ensure achievement of the objectives behind this arrangement.
- (v) The contract shall be effective from the date of actual contractual engagement.
- (vi) The selected personnel would assist the Secretary Agriculture/Director Agriculture/State Nodal Officer, NMSA-RAD as the case may be in carrying out various functions and also carry out the instructions issued by Department of Agriculture, Animal Husbandry & Cooperative, Govt. of Jharkhand from time to time in a time bound manner.
- (vii) Reservations as per the policy of Government of Jharkhand shall be applicable.
- (viii) Successful candidates on contract basis will have to sign a contractual agreement with the Director Agriculture, Jharkhand.
- (ix) The contractual engagement shall not confer any right or claim of extension/absorption under the Department of Agriculture, Animal Husbandry &

Cooperative, Govt. of Jharkhand.

- (x) Duly filled in application should reach in the office of Director Agriculture, Jharkhand, 1st Floor, Krishi Bhawan, Kanke Road, Ranchi-834008 on or before 06.07.2022 at 03:00 P.M. either by Speed post or Registered Post. Interested and eligible candidates are invited to submit the application enclosing their details C.V. in the prescribed format along with attested copies of mark sheets, caste certificate, residential certificate (both issued by SDO Level), professional qualification, experience, Character Certificate etc. and an application fee of Rs. 500/- (Rupees Five Hundred Only) in the form of Demand Draft in favour of Director Agriculture Jharkhand payable at Ranchi from any nationalized bank.
- (xi) Candidate applying for this post will have to personally appear before the interview board headed by the Competent Authority. The details of the interview will be posted on the website [www.sameti.org](http://www.sameti.org) and will also published in the news paper.
- (xii) After joining the organization the selected candidate has to execute a bond to serve the organization for a minimum period of one year. If s/he leaves this post during the bond period, s/he will have to pay an amount equal to the emoluments for rest of the bond period.
