#### **BRIEF DESCRIPTION**

As per the implementation of different Agriculture/ farm machinery promotional schemes the department has to empanel the manufacturer/ authorized dealer to supply the Tractors/ Self Propelled Machines / Agricultural Machines/Implements/ Tools/Items / Pump Sets/ HDPE Pipe etc on subsidy basis to the individual farmers and different type of farmers groups etc. under different programme of the Department Of Agriculture, Animal Husbandry & Co-Operative to be implemented the scheme of the financial year 2023- 24 to 2025 -26

Accordingly, EOI are invited only from Manufacturers/Authorized Dealer of the Manufacturer for the Jharkhand State to supply the Tractors/ Self Propelled Machines / Agricultural Machines/Implements/ Tools/Items / Pump Sets/ HDPE Pipe etc to the individual farmers and different type of farmers groups etc. under different programme of the Department Of Agriculture, Animal Husbandry & Co-Operative during the financial year 2023-24 to 2025-26 having at least 3 (Three) years of experience in manufacturing/ supply of relevant item & a minimum average annual turnover of last 3 years must be 10.00 (ten) lakhs or above.

The schemes have to be implemented through the different sanction schemes of all the Directorate/unit/sector/societies of Department of Agriculture, Animal Husbandry & Co-Operative, Jharkhand during year 2023-24, 2024-25 and 2025-26 or as decided by the department or by the competent authority.

## 1. Objective Of The EOI

To derive the best price for the specified quality and specification of Tractors/ Self Propelled Machines / Agricultural Machines/Implements/ Tools/Items / Pump Sets/ HDPE Pipe etc through price discovery method.

To ascertain the specified quality product is available to farmers/groups directly from the manufacturers or his authorized dealer.

To facilitate farmers/groups in procuring the specified product at minimum reasonable rate and at the same time ensuring the quality of supply as per specification.

To enable the farmer to get transparent and uniform subsidy across the state for the specified models of various Tractors/ Self Propelled Machines / Agricultural Machines/Implements/ Tools/Items / Pump Sets/ HDPE Pipe etc without compromising the quality.

Hence with above objectives and to safe guard the interest of farmer it is envisaged to empanel manufacturers or his authorized dealer to supply the implements at uniform subsidy.

#### 2. <u>Need For Empanelment</u>

In present scenario, due to lack of agreement on uniform price and quality of Tractors/ Self Propelled Machines / Agricultural Machines/Implements/ Tools/Items / Pump Sets/ HDPE Pipe etc along with its make & model, the farmers are facing troubles as they did not get transparent price for the specified item/machines.

The manufacturer or his authorized dealer differentiates price on the basis of the quality of material used by them and the farmers are not aware about the technicality at the time of purchase of such item/machines.

Hence to overcome the above problems with an objective to safe guard the interest of farmer it is envisaged to empanel manufacturer or their Authorized dealer to supply the Tractors/ Self Propelled Machines / Agricultural Machines/Implements/ Tools/Items / Pump Sets/ HDPE Pipe etc to the farmers/groups on 80-90 % subsidy or whatever is applicable by the

G.O. of the department (except big tractor) or as decided by the department from time to time as per the need by the department.

#### **General Information**

Due to lack of uniform price & quality, it is decided to describe the name/category/specifications etc of machines as given in **Annexure-I** 

Technically qualified bidders have to submit EMD & quote the financial bid/price (including all taxes etc) of machines given in **Annexure-I** only as and when asked/ published information on website/newspaper by the concerned officers as per the government order being issued from time to time.

Lowest quoted price of any bidder for a package of machine/ HDPE pipe etc. will be eligible for getting govt. subsidy under the sanctioned scheme of the department.

Farmers are free to choose/procure Tractors/ Self Propelled Machines / Agricultural Machines/Implements/ Tools/Items / Pump Sets/ HDPE Pipe etc from any empanelled bidder but subsidy of lowest quoted price will be given to those farmers/groups. The difference of amount as "farmers share" has to be paid by the farmers/groups to the concerned bidder. In no case supply has to be done to the farmers/groups without getting farmer's share or as per term & condition mentioned in government order.

The bidder has to submit a valid test report from any FMTTI, identified testing center by GoI Department of agriculture and farmer's welfare, or BIS/BEE/MNRE certificate as on the closing date of this EOI in which validity of test report must be clearly mentioned. Any exemption from test report will be as per GoI guidelines/orders or as per this EOI provisions. Any expired/validity date not mentioned or applied/pending Test Report BIS/BEE/MNRE certificate will not be entertained.

Submitted test report can be verified any time from issuing authority and in case of fake test report or altered/manipulated test reports a proper legal action can be taken against the bidder.

A summarize sheet of turnover of any 3 consecutive financial year 2020-21, 2021-22, 2022-23 & 2023-24 & any 3 consecutive years average annual turnover of last 3 years as Rs. 10.00 lakhs or above as per this EOI document. In case of MSE bidder turnover/ experience limit can be relaxed as per Jharkhand procurement policy/rule-2014 or any such related amendment.

EOI for Empanelment of the manufacturers or their authorized dealers the list of machines/ Equipment etc. are given in annexure-I. The technical list/name of machines/ Equipment etc Mentioned in this EOI document are specific but not exhaustive.

At any time a separate EOI can be invited to empanel more manufacturers/suppliers & other machines can be annexed or removed from Annexure-1.

The bidder has to provide one year onsite warranty on supplied product & has minimum 3 mandatory (or declared higher number) as free of cost servicing preferably on site i.e. farmers field/ at his home. The bidder has to replace HDPE pipe against any manufacturing defect within 15 days.

Solar Pump Sets warranty will be as per MNRE norms. It will cover a warranty of 5 year on solar pump set & 25 year on solar panel as per MNRE norms & in case of any fault in solar pump set/system the same will be rectified/replace free of cost within 15 days from receipt of such a complains from farmers/groups.

The single authorized dealers, who participate in the EOI, shall submit a signed copy from the Manufacturer with duly indicating the authorization to supply the only the specific make and model of item from bidder/authorised dealers.

The rates when asked has to be quoted for this EOI shall be for applicable only to the item specified & technically evaluated/sanctioned as mentioned in Annexure-I with full specification (hp, capacity& other technical detail specification) and inclusive of all taxes, GST, insurance, registration (for tractors), duties, cess, transportation/loading and unloading and installation charges if any during the contract period.

The authorised officers of the Department/JAMTTC will have an option/right to inspect the manufacturing premises of the various manufacturing units/product of any empanelled firms, who participate in this EOI, to ascertain the manufacturing and production capabilities, quality checking facilities / R&D establishments.

Authorized Dealer should possess required experience, turnover, GST certificate and PAN Number and all other related statutory requirements.

Authorized Dealer or its director/proprietor/partner of any firm should not have been blacklisted by any of the Government department/organizations.

The **Director**, **Soil Conservation**, **Jharkhand**, **Ranchi** reserves the right to restrict the number of authorized dealer for any manufacturer if it deems fit.

As per government order or any other order the machines/equipments have to be GEO tagged & to take color photograph onsite i.e. farmers/ group residence with clearly mentioned date, latitude & longitude etc.

Every tractor must have GPS enabled system (Recharged for 3 years from date of installation) for monitoring & evaluation purpose up to 3 financial years. There should be provision to recharge the GPS after three years.

Every tractor, power tiller or self propelled machines has minimum 3 mandatory free of cost servicing preferably onsite during warranty period of one year.

Every tractor, power tiller or self propelled reaper and self propelled Rice transplanter, self propelled machines has to fix an approved logo of the GoJ/department.

#### **Deposit of Document Fee**

#### **Registered Micro and Small Enterprises (MSE)**

#### Earnest Money Deposit (EMD)

#### **Registered Micro and Small Enterprises (MSE )**

The MSE bidder has to submit a certificate from the concerned officer of Jharkhand Industry Department that the bidder is exempted under the Jharkhand Industrial Procurement policy & he is entitled for exemption /not to submit document fee and EMD (Form T-14) or as per Jharkhand procurement policy/rule-2014 or any such related amendment.

Other Registered firms- The EMD has to be submitted when asked to submit financial bid against each item as given in Annexure-I of this document or any additional list. EMD/ Performance security shall be submitted in the form of Demand Draft in favour of "Director, Soil Conservation, Jharkhand, Ranchi" payable at Ranchi, or in favour of concerned Directors/officers/Agency separately for such a scheme sanctioned under his control.

EMD of the successful bidder will be retained by the Directors/officers as performance/security deposit and will be refunded after the validity period of the scheme but it shall be forfeited in case of violation of the EOI terms and conditions.

The EMD/ Performance Guarantee may be forfeited:

Document in support of Minimum of 3 yrs experience of manufacturing/supply of Agriculture equipments/machines etc as **Form T5**.

Agreeability to provide one year onsite warranty from the date of supply for repairing of the Machine/Equipments as in Annexure-1 & to replace HDPE pipe against any manufacturing defect within 15 days. Replacements/servicing/repairing shall be free of cost within the warranty period. Form T6.

The bidder has to submit the valid test report from FMTTI, identified testing center by GoI, BIS/BEE certificate as on the closing date of this EOI in which validity of test report must be clearly mentioned. The bidder should submit the required valid test report or BIS/BEE/MNRE certificate of the machines/equipment/pumpset/solar pumpset/HDPE pipes etc. in Form-T7.

The bidder should submit the availability of Authorised Dealer, Sales & service center of Manufactures to provide the services in all the district of Jharkhand as **Form T8**.

The Bidder has to submit a valid GST registration certificate & copy of filed GST return of December 2023 (Form 3B), & a copy of which should be enclosed as Form T9.

. The Bidder should compulsory submit an original copy of summarize sheet of Minimum annual average turnover of last consecutive 3 years must be 10.00 (Ten) lakhs. A summarize sheet of turnover of any 3 consecutive financial year 2020-21, 2021-22, 2022-23 & 2023-24 & any 3 consecutive years average duly signed & certified by registered CA with UDIN should be compulsory & countersigned by bidder as **Form T10**.

The Bidder should submit Photo Copy of Update Income Tax Return Acknowledgement Receipt of last any consecutive 3 Assessment years i.e. Assessment year 2020-21, 2021-22, 2022-23 and 2023-24 should be Enclosed as **Form T11**.

The Bidder shall submit Certificate of Authorization to sign the document as Form T12.

The Bidder shall submit Purchased/ downloaded EOI document should & Each Page should be signed with stamped & Enclosed with technical bid as Form T13.

In case of MSE bidder desirous exemption not to submit document fee and EMD as per Jharkhand Industrial Procurement policy he has to submit form **T-14** 

The Bidder shall submit a self declaration form as Form -T15

# **Guidelines For Submission**.

Bidder are advised to submit their EOI Proposal strictly based on the specifications, terms and conditions contained in the EOI document and subsequent revisions /amendments, if any.

The EOI shall be prepared and submitted by typing or printing in English on white paper in consecutively numbered pages duly signed by the authorized signatory with company seal affixed on each page. Any part of the EOI, which is not specifically signed by the authorized signatory and not affixed with company seal, shall not be considered for the purpose of evaluation.

All the Performa must be on the Bidder official letter head (if specified). Any change in words/sentence of the Performa will not be allowed.

The offer shall contain no erasures or overwriting except as necessary to correct errors made by Bidder. The person signing the offer shall initial & seal on such corrections.

Complete EOI document including all enclosures should be submitted in hard bond or spiral binding and all pages should be numbered (except leaflet / catalogue) and must be signed by the company's authorized signatory & seal of the company otherwise proposal will be rejected.

The interested bidders with requisite experience & required papers should submit firstly the Technical Proposal and those bidders who technically qualify in the Technical evaluation may submit the Financial Proposal when asked to submit as per the need of sanctioned programmes/schemes.

The technical Proposal should not contain price of any item & in any such cases, even if found anywhere, shall not be given any cognizance.

When asked to submit the financial proposal through EOI/Tender from technically qualified bidder for such a machine/implement as mentioned in ANEEXURE-1 they have to submit Financial Proposal as per provision when asked by Respective **Directors/officers/agency** of the department.

Technical proposal (check List form T-1 to T-15,) should be submitted with relevant documents/papers in support of the above criteria along with proof so as to enable appropriate evaluation.

Other relevant technical document/Test Report etc in favour of technical specification etc. may be submitted as Additional Technical Booklet in the same envelop (all pages spirally bonded together) & inserting page no. on each paper. No loose papers will be accepted. No any separate paper will be considered in technical evaluation committee.

The person signing the bid document should must be authorised signatory & has to sign with official stamp on all pages of the EOI document otherwise such EOI will be summarily rejected.

#### **Financial Bid Document**

When asked to quote the price the quoted rate/price should be inclusive of all taxes, Freight, registration, Insurance, Installation charges, all necessary tools/kits, basic accessories and for diesel/petrol/ electric/ Pump Set Includes necessary tools, clamps, Suction Pipe 25 ft, GI bent, connecting wire - 100ft, starter switch etc., for electric/submersible pumpset etc or as per the provision of invited EOI/Tender.

#### **Selection Process**

A designated tender Committee will evaluate the technical document received & on the basis of technical assessment the bidder will be declared "Technically qualified". Technical assessment will be based on technical evaluation criteria as mentioned in paragraph/subparagraph of 6.0 & 7.0.

On the basis of technical assessment the technically qualified bidders will be enlisted & the financial proposal from only those bidders will be invited as and when required.

The financially enlisting of bidders to supply Agriculture equipments/machines as per Annexure-I will be done on the basis of specification & quoted lowest rate. The bidders have to supply their product on the basis of farmers share fixed as per lowest price basis.

At the time of submission of financial bid evaluation the designated tender Committee/ competent authority may ask to negotiate the quoted price from the bidders to decide lowest possible competitive rate.

#### Supply Procedures

The supply of machines & bills may be issued either by empanelled Bidder or duly authorized dealer of manufacturer as mentioned in this EOI (T-8). Any other dealer or sub dealer/person not mentioned in T-8 of this EOI shall not be considered to supply or raise the bill and this will be treated as financial irregularity. The bills should be raised only in the name of selected small & marginal farmers/self help group/ Mahila Sakhi Mandal/ Farmer's Group/Lamps-Packs/VO/FPO etc. or to the Directors/officers/JAMTTC etc in case of GPS or any such supply order.

In case of any differences/dispute between the bidder and dealer of a particular district, the bidder can restrict the supply from the dealer as mentioned in T-8 and in that case either bidder or any other dealer mentioned in T-8 can supply or raise the bills. The bidder can change the dealer only after the approval by manufacturer by cancellation of present dealer & duly appointed a new dealer in the start of next financial (only 1<sup>st</sup> April to 31<sup>st</sup> May), such a dealer can supply the material only after the approval of competent authority i.e. to whom EMD has been deposited, no field officers can accept such a changes at his level.

The bills should be submitted in triplicates, if the subsidy is to be sanctioned under single budget Head. However, if the subsidy is sanctioned under two/three different budget heads, the bills should be submitted separately for each budget head.

In each bill the name of implements, specification, serial number, total amount, GST amount, farmers share etc have to be clearly mentioned.

The beneficiaries have the liberty to choose any brand and model enlisted with the prices with the empanelled bidder and obtains the equipment/machine etc only if it is satisfied with the price of the product.

The beneficiaries shall be free to select any eligible empanelled Implements of their choice from the empanelled bidder or enlisted authorised dealer network (T-8), and then the bidder/dealer shall supply the required item to the concerned group/individual only after collecting the farmers share or total amount of the machines etc. only through RTGS/NEFT.

With approval/provision in Government order/competent authority to enable the smooth supply of small machines/implements a beneficiaries share below Rs 5000.00 may be collected by digital payment method from individual farmers/their farmer's family (spouse, son or unmarried daughter only which can be verified from their Adhar Card) account by giving money receipt from suppliers to the beneficiaries.

After the supply of the equipment and verification by the Department Officials the subsidy amount will be transferred through RTGS/NEFT to any of mentioned process as described in government relevant order.

In brief payment to suppliers can be either of any 3 options-

i) The amount of subsidy will be transferred directly to the Beneficiary's bank account if pumpset/ machine/equipment/ etc are purchased at their full expense. or

ii) On purchase of pumpset/ machine/equipment/ etc through bank loan account the amount of subsidy amount will be transferred to the concerned bank from where loan is taken. or

iii) On purchase of pumpset/ machine/equipment/ etc through manufacturer/authorised dealer and on a written request of Beneficiary's the amount of subsidy will be transferred to the bank account of manufacturer/authorised dealer of the concerned manufacturer duly after verification by the concerned officers.

No payment has to be made to any dealer/sub-dealer not mentioned in this EOI (T-8) or changed dealer as mentioned in above paragraph 10.2.

The empanelled Bidder shall record the full detail of tractors/pumpset/ machine/equipment/etc with Make & Model Number/ Serial number/ Engine Numbers/Chassis Number etc, in the Delivery Challan and bills.

The bidder should submit the list of dealers to the groups/officers with full address & phone no, where the spare parts of the supply item be available.

#### Penalties For Non-Compliances, Violation And Non Performance:

Violations of terms and conditions of EOI.

a) If the material supplied by the bidder does not meet the specific standards.

b) Bidder raising false bills/ bills without supply of the machines/implements/pumpset etc.

c) In the event of failure of the Bidder to execute the order within the specified period or maximum 15 days from the date of transfer of farmers share/ intimation, the order shall be treated as cancelled.

d) If any information provided by the bidder is found to be factually false or misleading such bidder will summarily be rejected at any time during the validity period of the EOI and quoted rates and liable for penalties as applicable.

e) The Payment claim will not be accepted for the item supplied without paying of farmers share by the group/farmers, geo tagged photographs/ verification from concerned officers and registration in case of tractors etc.

f) All the transaction from the group/farmers to bidder will be only through bank transaction e.g. RTGS/NEFT/DD only to the account number provided in this EOI or any such details provided at the time of financial bid invited.

In case of non supply of pumpset/ machine/equipment/ etc within the stipulated period of 15 days from date of receipt of farmers share/ intimation a penalty of Rs 100.00 per day may be impose on concerned bidder/supplier and after 30 days the farmers share have to be refunded to the concerned beneficiary's account. In case of failure to supply the machines etc. such an amount will be deducted from EMD/performance security of bidder & appropriate legal action will be taken against such bidder/suppliers.

#### **Blacklisting Debarment**

The Manufacture/Authorized dealer of the manufacturer shall furnish an affidavit from a Notary/ $1^{st}$  class magistrate in the Performa given as form T2, mentioning "that neither the

agency nor any person/directors/member has ever been blacklisted by any Govt. agency/Department/Ministry nor convicted for any criminal offence by any court of law.

As per the clauses of paragraph 10.0 & 11.0 if the empanelled bidder did not supply/submits the report to the department then after intimation of departmental letter (up to 3 times reminder) to the bidder, then **Director Soil Conservation**, **Jharkhand Ranchi** / competent authority can terminate the rate contract of such bidder at any time without any reason.

#### **Contents Of Envelopes**

The EOI document shall be typed or written in indelible ink and shall be signed by the person or persons duly authorized to bind the EOI Contract.

A Written power-of-attorney accompanying the EOI document should support the Letter of Authorization.

The authorised person signing the EOI should sign all pages of this EOI document otherwise such EOI document will be reject (photo copy of signature not allowed).

#### **Preparation Of EOI Document**

#### Language of EOI document

The EOI document prepared by the Manufacture/Authorized Dealer, as well as all correspondence and documents relating to the EOI document exchanged by the Manufacture/ Authorized Dealer and the Departmental EOI Committee shall be in English only.

**EOI Document Currency** - Prices shall be quoted in Indian Rupees only, both in figure and words. In case of difference between words and figure the proposal will be summarily rejected.

#### Validity Of EOI

The validity period of technical enlistment will be effective for financial year 2023-24 to 2025-26 as per this EOI.

The Director, Soil Conservation, Jharkhand, Ranchi, have right to invite anymore/ additional EOI in financial years 2023-24, 2024-25 & 2025-26 to empanel additional agency or additional implements/machine as mentioned in Annexure-I and in that case the bidders who have already enlisted may apply in fresh on technical ground.

The validity period of quoted rates should be valid up to the specified period or one year from the date of issue of office order as mentioned in financial bid invitation. On mutual consent & with approval of The Director Soil Conservation, Jharkhand, Ranchi or Directors/Agency/ or the Department it can be extended for certain period/one year after the expiry of first year.

#### **Other Important Information**

The Bidder should have service centres in Jharkhand State is only eligible to participate in the EOI. In this regard documents should be furnished in T-8. In case of dealers and service centre are different the list can be enclosed accordingly.
